Respected Sir,

I SI Arun Kr. Bose of Bandwan PS submitted report that against one person namely Koleswar Hansda S/O Lt. Siru Hansda of vill. Kendboni, P.S. Bandwan, Dist. Purulia. Today (03.05.17) during my Spl. mobile duty at about 17:45 hrs received a credible source information over mobile phone that one person namely Koleswar Hansda S/O Lt. Siru Hansda of vill. Kendboni, P.S. Bandwan, Dist. Purulia making & selling illicit liquor in his house at Kendboni village under Bandwan PS. This refers to Bandwan PS GDE No. 99, Dtd-03.05.17. Accordingly I inform to O/C Bandwan PS over mobile phone the above noted reference & he direction me to work out the said information. Then myself accompany officers and forces namely SI Montaz Sheikh, ASI Jashasri Bhattacharya, C/1457 Nityaranjan Rajwar, JC/390 Samik Choudhary, JC/1023 Biplab Dule, JC/1317 Sunil Sahoo all are Bandwan PS left for Kendboni village to work out the said source information. Then, at about 18:25 hrs I reached at Kendboni village and found the said person was making Illicit Liquor in his house under Bandwan PS. So, with the help of accompany officer & force I searched thoroughly with proper decency and maintains all legal formalities and found that the aforesaid person making illicit liquor. But he seen police party fled away on the spot towards Kendboni forest side. After interrogation his family members and other disinterested villagers collect his identity above noted there after I also seized illicit liquor approx 31 (thirty one) liters in a black plastic container (details in seizure list) after preparing proper seizure list duly signed by the witnesses and labeled. Total 31 liters illicit liquor has been seized. Koleswar Hansda S/O Lt. Siru Hansda of vill. Kendboni, P.S. Bandwan, Dist. Purulia committed offence U/S-46A(C) B.E. Act 1909. One seizure copy pasted in his house (main door) in presence of local persons.

Under the above circumstances, I therefore pray before you that a cog case may kindly be started U/S 46A(C)B.E. Act 1909 against the fled accused person namely Koleswar Hansda S/O Lt. Siru Hansda of vill. Kendboni, P.S. Bandwan, Dist. Purulia and arrange for its investigation.
