I do here by brought under arrest one accused person namely Shankar Sing Sardar (age-25 yrs) S/O-Lt. Mangal Sing Sardar of Vill-Yuktidih, PS-Ghatshila, Dist-East Singbhum, Jharkhand, along with one seized Motor Cycle one black & yellow coloured Honda SP Shine Motor Cycle having Chassis No-ME4JC73AEKG013997, Engine No-JC73E-G-0027047 and lodging written complaint against Shankar Sing Sardar (age-25 yrs) S/O-Lt. Mangal Sing Sardar of Vill-Yuktidih, PS-Ghatshila, Dist-East Singbhum, the fact of the case in brief is that today i.e. on 09.06.20 at 18.15 hrs I received a credible source information that one Shankar Sing Sardar S/O-Lt. Mangal Sing Sardar of Vill-Yuktidih, PS-Ghatshila, Dist-East Singbhum is a Motor Cycle thieve and he had kept concealed a motor cycle (which has been procured by means theft) in his father-in-law's house at Pargora village under Bandwan PS, Dist-Purulia with a view to sale. Accordingly, noted the fact in G.D which refers to Bandwan PS GDE No-341, Dtd 09/06/20 and myself along with force left for Pargora village to work out the said source information.

Then, I conducted search into the father-in-law's house of said Shankar Sing Sardar as per source information & seized one black & yellow coloured Honda SP Shine Motor Cycle having Chassis No-ME4JC73AEKG013997, Engine No-JC73E-G-0027047 after preparing proper seizure list duly signed by the witnesses as he failed to produce any valid documents in respect of said seized Motor Cycle though sufficient time was given. The said motor cycle was kept concealed at the back side of the house covering through a tarpaulin. During interrogation, he confessed that he had stolen the seized Motor Cycle and he further disclosed that he would help us to secure arrest of rest involved accused persons. After that, I arrest him after prepare proper arrest memo duly signed by the witness.

Hence, I pray to you that a cog case may kindly be started U/S-379/411/414 IPC against Shankar Sing Sardar (age-25 yrs) S/O-Lt. Mangal Sing the arrested accused person namely Sardar of Vill-Yuktidih, PS-Ghatshila, Dist-East Singbhum, Jharkhand and arrange for its investigation.
