Sir,

I do hereby lodge complaint, empowered by enabling "The Electricity Act, 2003" subsequently electricity act- 2007, to the effect that Shri Subhan Mahato S/O Kandru Mahato of Vill- Bhabanipur was enjoying electricity unauthorizedly by illegal bypassing from PVC service cable before meter and he has committed theft of electricity U/S 135(1)/B of the electricity (Amendment act-2007).

On 06.01.2017, I Sri SUBAL CH. DEY, D.E & S.M., BARABAZAR CCC along with

- (1) AMIT SING, S.A.E.(E), S/o Sanatan Sing, Vill-Laupara, P.S - Beliabera, Dist- Paschim Medinapore
- (2) Chandi Chran Karmakar, (A.C.M.), S/O Lt. Gurupada Karmakar, Vill- Katwa, P.O.+P.S.-Katwa, Dist- Burdwan

At About 11.45 a.m., entered into the premises of Shri Subhan Mahato S/O Kandru Mahato of Vill.- Bhabanipur and inspected his premises at Vill.- Bhabanipur P.S Barabazar, P.O. Bhabanipur, DIST- Purulia.

During inspection, it was found that. Shri Subhan Mahato S/O Kandru Mahato of Vill.- Bhabanipur was enjoying electricity illegally bypassing meter through PVC cable with the damage of incoming service cable before meter in his premises at Bhabanipur having connected load 0.6 KVA.

From the above arrangement he was using the following equipment :

01. PVC cable 2 core 4 Sq. mm, (25 mt. Approx)
02. 4 Nos of Lamp (60 Watt each)
03. 2 Nos Fan (60 watt each)
04. 1 No Color T.V.(150 watt)

Out of which I seized the following articles:

1. PVC cable 2 core 4 Sq. mm, (25 mt. Approx)
2. 1 No Lamp (60 Watt)

Seizure list was prepared at site and accused person was fled away. After process of inspection and seizure list we left the premises at about 11:55 a.m.

The said person has committed an offence U/S 135(1)/B of electricity act 2003 subsequently electricity (Amendment) act- 2007.

You are requested to take cognizance of this complaint and treat it as F.I.R and action may be taken as per rule.
