In producing herewith the accused person namely Barid Baran Tadu (45 Yrs) S/o akhiram Tadu of Village- Jharnakocha, PS-Barabazar, Dist.-Purulia along with seized at Label 'A' and (2) One plastic jaricane containing approx 15 ltrs of ID liquor marked A, as sample and marked as Label A1 along with seizure list.

I do hereby lodge complaint that to-day on 22.01.17 myself PSI Subhash Malik along with C/678 Ram Prasad Paine & JC/960 Shyam Sundar Gulimajhi left P.S for performing raid duty under PS area. During raid I received an information from my reliable source that one person is selling I.D Liquor in a house at Vill. - Jharnakocha under PS-Barabazar, Dist.-Purulia. Then we proceeded towards there, keeping our Govt. Vehicle (Sumo-Victa-WB 26 K-5475) at a considerable distance. Then we proceeded on foot towards the place. Then I collected two disinterested witness and briefed them about the fact and requested them to accompany police and they agreed to assists us during working out of the received information and they disclosed their identity as (1) Jyatilal Majhi S/o Late Hazari Majhi of Village- Jharnakocha, PS-Barabazar, Dist.-Purulia and (2) Bholanath Murmu S/o Late Chatulal Murmu of do. We arrived on the spot and found that one person was selling liquor to the addicted people from one black colour plastic Jaricane. Getting the scent of police 3/4 persons fled away but we able to detain one person and interrogated him. During interrogation he disclosed his name and particulars as noted above and also told that he was selling I.D. Liquor keeping in his possession to the addicted people without any valid license and documents. Then I seized the above mentioned articles in between 10:15hrs to 11.35 hrs. after making proper seizure list and labeled the seized article on the spot in presence of witnesses, Barid Baran Tadu (45 Yrs) S/o Lakhiram Tadu of Village-Jharnakocha, PS-Barabazar, Dist.-Purulia U/S 46A(c) B.E. Act.

Under the above noted circumstances I request that a case u/s 46A(c) B.E. Act may kindly be started against the arrested accused person namely Barid Baran Tadu (45 Yrs) S/o Lakhiram Tadu of Village- Jharnakocha, PS-Barabazar, Dist.-Purulia and arrange for its investigation.
