I do hereby lodge complaint, empowered by enabling "The Electricity Act, 2003" subsequently electricity act-2007, to the effect that Shri Sudhir Kalindi S/O Late Indra Kalindi was enjoying electricity unauthorizedly by illegal hooking from nearest LT overhead line and he has committed theft of electricity U/S 135 of the electricity (Amendment act-2007).

On 07.02.2017 I, Sri Subal Ch. Dey, D.E & S.M., BARABAZAR CCC along with

- (1) AMIT SING, S.A.E(E), S/O SANATAN SING
- (2) JALAD BARAN GHOSHAL, (L.M) S/O Lt. MADHUSUDAN GHOSHAL

Entered into the premises of Shri Sudhir Kalindi S/O Late Indra Kalindi and inspected his premises at Vill- Manpur, Dist- Purulia, P.S- Barabazar.

During inspection, it was found that Shri Sudhir Kalindi S/O Late Indra Kalindi was enjoying electricity illegally by using direct hooking from the nearest LT overhead line in his premises at Manpur with the help of single flexible PVC copper (2 core) conductor of approximately 3/8". He was using two lamps of 100 watts and 60 watts each.

The said person has committed an offence U/S 135(1)/a of electricity act 2003 subsequently electricity (Amendment) act-2007.

You are requested to take cognizance of this complaint and treat it as F.I.R and action may be taken as per rule.
