Re: F.I.R. against Unauthorised use of Electricity against Saddam Ansari S/O Kamaluddin Ansari of Vill. Turku P.S. Barabazar, Dis. Purulia having consumer Id. 201825154 and meter No. B3624165.
 Sir,

I do hereby lodge complaint, empowered by enabling "The Electricity Act, 2003" subsequently electricity act-2007, to the effect that Saddam Ansari S/O Kamaluddin Ansari of Vill.- Turku was enjoying electricity unauthorisedly by illegal bypassing from PVC service cable before meter with the help of 1*2 core wire and he has committed theft of electricity U/S 135(1)/B of the electricity (Amendment act-2007).

On 08.02.2017, I Sri SUBAL CH. DEY, D.E & S.M., BARABAZAR CCC along with

- (1) AMIT SING, S.A.E.(E), S/O Sanatan Sing, Vill-Laupara, P.S - Beliabera, Dist- Paschim Medinapore
- (2) Sankar Ch. Mahato, S/O - Let Probadh Kumar Mahato Vill- Nadiha, P.S- Purulia (T) Dist- Purulia

At About 2.05 p.m., entered into the premises of Saddam Ansari S/O - Kamaluddin Ansari of Vill.- Turku and inspected his premises at Vill.- Turku P.S Barabazar, DIST- Purulia.

During inspection, it was found that Saddam Ansari S/O Kamaluddin Ansari of Vill.- Turku was enjoying electricity illegally bypassing meter through PVC cable with the damage of incoming service cable before meter in his premises at Turku having connected load 0.48 KVA.

From the above arrangement he was using the following equipment :

01. PVC cable 2 core 4 Sq. mm, (15 mt. Approx)
02. 2 no Nos of Lamp (60 Watt each)
03. 2 Nos Fan (80 watt each)
04. 1 No Color T.V.(100 watt)
05. 02 no CFL (15 watt each)

Out of which I seized the following articles:

- 1 Bypassing arrangement PVC cable 2 core 4 Sq. mm, (15 mt. Approx)
- 2 1*2 core wire (2ft) with 2 ft bulb and holder(1 no)

Seizure list was prepared at site and accused person was fled away. After process of inspection and seizure list we left the premises at about 02.31 p.m.

The said person has committed an offence U/S 135(1)/B of electricity act 2003 subsequently electricity (Amendment) act-2007.

You are requested to take cognizance of this complaint and treat it as F.I.R and action may be taken as per rule.
