Sir,

In producing herewith the arrested accused person namely Krishna Kishore Gorai (25 yrs) S/O Hariram Gorai of Vill.+P.O.-Bhikhari Chelima, P.S.-Barabazar, Dist- Purulia along with following seized articles (1) One black colour plastic Jaricane containing about 12 ltrs of I.D liquor marked as "Label 'A'". (2) One plastic bottle containing 250 ml of I.D liquor taken from label 'A' as sample and marked as "Label A1" along with seizure list.

I do hereby lodged complaint that to-day on 06.03.17 at 18.05 hrs. myself PSI Subhash Malik along with C/236 Ram Chandra Gorai and C/1203 Partha Sarathi Bose left P.S for performing raid duty under PS area. During raid I, received an information from my reliable source that one person is selling I.D Liquor in a house at Bhikhari Chelima, Goraipara More under P.S.-Barabazar, Dist- Purulia. Then we proceeded towards there and reached at 18.45 hrs., keeping our Govt. Vehicle at a considerable distance. Then we proceeded on foot towards the place and try to collect independent public witness but no one agreed to assist the police to work out the information. We arrived on the spot and found that one person was selling I.D.liquor to the addicted people from one black colour plastic Jericane. Getting the scent of police 3/4 persons fled away but we able to detained one person and interrogated him. During interrogation he disclosed his name and particular as noted above and also told that he was selling I.D. Liquor keeping in his possession to the addicted people without any valid license and documents. Then I seized the above mentioned articles in between 19:15 hrs and 19:55 hrs. after making proper seizure list and labeled the seized article on the spot in presence of witnesses, then I arrested Krishna Kishore Gorai (25 yrs) S/O Hariram Gorai of Vill.+P.O.-Bhikhari Chelima, P.S.-Barabazar, Dist- Purulia U/S 46A(c) B.E. Act.

Under the above circumstances Krishna Kishore Gorai (25 yrs) S/O Hariram Gorai of Vill.+P.O.-Bhikhari Chelima, P.S.-Barabazar, Dist- Purulia committed an offence U/S 46A(c) B.E. Act. So, I request you to start a case against the said accused U/S 46A(c) B.E Act.
