Entered into the premises of Shri Krishnapada Mahato C/O Shri Late Ananda mahato and inspected his premises at Vill- Bhabanipur, Dist.- Purulia, P.S- Barabazar.

During inspection , it was found that Shri Krishnapada Mahato C/O Shri Late Ananda mahato was enjoying electricity illegally by using direct hooking from the nearest LT overhead line in his premises at Bhabanipur with the help of single bare flexible PVC aluminum conductor of approximately ten meters.

The said person has committed an offence U/S 135(1)/a of electricity act 2003 subsequently electricity (Amendment) act-2007.
