I do hereby lodge complaint, empowered by enabling "The Electricity Act, 2003" subsequently electricity act-2007, to the effect that Shri Asgar Momin S/O Shri Late Bhiku Momin was enjoying electricity unauthorizedly by illegal hooking from nearest LT overhead line and he has committed theft of electricity U/S 135 of the electricity (Amendment act-2007).

On 07.04.2017 I, Sri Subal Ch. Dey, D.E & S.M., BARABAZAR CCC along with

- (1) AMIT SING, S.A.E(E), S/O SANATAN SING
- (2) CHANDICHARAN KARMAKAR, ACM, S/O LATE GURUPADA KARMAKAR

Entered into the premises of Shri Asgar Momin S/O Shri Late Bhiku Momin and inspected his premises at Vill- Dhadanga (Majhipara), Dist.- Purulia, P.S- Barabazar.

During inspection, it was found that Shri Asgar Momin S/O Shri Late Bhiku Momin was enjoying electricity illegally by using direct hooking from the nearest LT overhead line in his premises at Dhadanga (Majhipara) with the help of single bare flexible PVC aluminum conductor of approximately nine meters.

The said person has committed an offence U/S 135(1)/a of electricity act 2003 subsequently electricity (Amendment) act-2007.

You are requested to take cognizance of this complaint and treat it as F.I.R and action may be taken as per rule.
