Sir,

I do hereby lodge complaint, empowered by enabling "The Electricity Act, 2003" subsequently electricity act-2007, to the effect that Shri Manik Karmakar S/O Lt Chutu Karmakar of Vill- Latpada was enjoying electricity unauthorisedly by illegal hooking from the nearest LT Overhead line and he has committed theft of electricity U/S 135(1)/B of the electricity (Amendment act-2007).

On 20/04/2017, I Sri SUBAL CH. DEY, D.E & S.M., BARABAZAR CCC along with

- (1) AMIT SING, S.A.E.(E), S/o Sanatan Sing, Vill-Laupara, P.S – Beliabera, Dist- Paschim Medinapore
- (2) Malad Baran Ghosal, (L.M.), S/O Lt. Madhusudan Ghosal, Vill+P.O.- Khajurdihi, P.S. Katwa, Dist- Burdwan

At About 12 p.m., entered into the premises of Shri Manik Karmakar S/O Lt Chutu Karmakar of Vill. - Latpada and inspected his premises at Vill.-Latpada P.S Barabazar, P.O. Herbona, DIST- Purulia.

During inspection, it was found that. Shri Manik Karmakar S/O Lt Chutu Karmakar of Vill. - Latpada was enjoying electricity illegally by hooking the nearest LT overhead line with the help of a hooking device and PVC flexible cable approx. eight meters in length. Connected load during inspection was 0.14 KVA.

From the above arrangement he was using the following electrical appliances:

- 01. One Table Fan (60 watt).
- 02. One Lamp (60 Watt)

Articles seized during inspection:

- 1. PVC flexible cable (08 mts. Approx) with hooking device.

Seizure list was prepared at site and accused person fled away. After process of inspection and seizure list we left the premises at about 12:10 p.m.

The said person has committed an offence U/S 135(1)/B of electricity act 2003 subsequently electricity (Amendment) act-2007.

You are requested to take cognizance of this complaint and treat it as F.I.R and action may be taken as per rule.
