I beg to state that today (04.06.2020), I along with my accompanied force namely C/-357 Gopal Biswas & C/- 185 Rajesh Kr. Ray returned to PS and submitted a written complaint against the following persons (1) Brindaban Mahato S/O Late Padmalochan Mahato (2) Bhagya kaibartya S/O Late Chakradhar Kaibartya (3) Bishnu Kaibartya S/O Atul Kaibartya (4) Durjodhan Mahato S/O Jyoti Mahato (5) Kalachand Mahato S/O Late Premchand Mahato (6) Bhageswar Mahato S/O Late kalachan Mahato (7) Rupchand Mahato S/O Sambhu Mahato (8) Rabilal Mahali S/O Kanthiram Mahali (9) Nibaran Ghunia S/O Budhan Ghunia (10) Satrughna Mahato S/O Naru Mahato (11) Lalmohan Mahato S/O Parikshit Mahato (12) Dhananjoy Mahato S/O Parikshit Mahato (13) Ramesh Mahato S/O Gangadhar Mahato (14) Gurucharan Mahato S/O Gangadhar Mahato (15) Buchan Mahato S/O Gangadhar Mahato (16) Bangshi Mahato S/O Gangadhar Mahato (17) Jiten Singh Sarder S/O Sambhu Singh Sarder (18) Santosh Mahato S/O Chutulal Mahato and other's all of Vill- Rupapetya, PS- Barabazar, Dist- Purulia, to the effect that during night patrol duty vide Barabazar PS GDE No- 169 & C.C No- 1726/2020 Dtd. 03.06.2020 received a source information at about 22.05 hrs that a mass gathering took place end of Rupapetya village near pond over the issue of disputed land and every chance to clash among them. Informed to I.C and as per direction myself along with force rushed to the spot, on way informed concern V.P Birinchi Mahato to reached the spot. Accordingly he also reached the spot along with us at 23.15 hrs seen the Police party the mob fled away from the spot and found that a mass gathering was gather there. This may spread infection. Their malignant act is likely to spread infection of disease which is dangerous to life.

Held an enquiry and learnt that from the reliable sources that the above noted persons and others were gather there over the issue disputed land and a hot altercation took place among them, using very indecent languages to each others, showing with adamant attitude which may causes any untoward incident of that locality. They violated the lock down rules though lockdown is going on throughout the District of Purulia in view of Pandemic of COIVD-19 outbreak vide Govt. of India consolidated order No-40-3/2020-DM-1 (A) Date-24/03/2020 and further modified dated-25/03/2020, 27/03/2020, 02/04/2020, 03/04/2020 and 10/04/2020 for complete restriction measure. As such the above persons violated the order during this pandemic situation duly promulgated by Govt. vide Order No- 40-3/2020-DM≈1(A), GOI, MHA, 30th May 2020. In this time any non essential movement in between 21.00 hr to next morning 05.00 hrs are strictly restricted. The above noted persons broke the norms intentionally to cause more hindrances in the society.

I along with force performing patrolling in and around the place and pushed the innocent others local villagers who were whispering about the matter in front of their door to prevent any re-occurrence of such type of illegal activities and to prevent any untoward incident about the matter. After the situation as usual deputed local Civic volunteers I along with force left the place to move others places for night patrolling duty at about 02.15 hrs Dtd. 04.06.2020.

After completion of night patrolling duty, on arrival at PS I type this letter of complaint at our PS is the involved persons noted above and others of Vill-Rupapetya, PS-Barabazar, Dist-Purulia as
