Sir,

I SI Lakhi Kanta Pati of Barabazra ps would like to submit this written complaint against Bhaqirath Mahato(48) S/o Lt Heramba Mahato of Bamu, Ps:- Barabaray and Nirmal Ch Mahato (69)S/o Lt Anada Lal mahato of Berada, Majhapara (near school), PS:- Barabazar to the effect that yesterday (3.6.2020) the above noted persons entered at Berada High School for political affairs which is an assigned quarantine centre in c/w COVID 19.

I beg to state that today (04.06.2020), I learned from VP Rajkumar Kalindi that yesterday (3.6.2020) the above noted persons entered at Berada High School for political affairs. Today they made it public also by face book. As I was directed by IC Barabazar PS to find out whether they broke the lock down norms or not myself left for Berada area vide GD entry no 203 dt 4/6/2020.

During my primary enquiry it came to light that yesterday (3.6.2020) the above noted persons entered at Berada High School for political affairs which is an assigned quarantine centre in c/w COVID 19 by Block administration. They kept 14 migrant labours there as it was treated as institutional quarantine centre. As per COVID guide line no should take entry at that place for political activities etc. But violating every norms these persons took entry at that sais I.Q.C at about 14.30 hrs on 3/6/2020.

Through public servants and through media etc for prevention of attack from CORONA Virus the guide lines were circulated. It is also revealed that said persons are very desperate types of political personalities and found creating annoyance to the society by such type of illegal activities avoiding govt order in this critical situation. They entered at I.Q.C in very much unhygienic way and without any health care articles. This may spread infection. Their malignant act is likely to spread infection of disease which is dangerous to life.

They violated the lock down rules though lockdown is going on throughout the District of Purulia in view of Pandemic of COIVD-19 outbreak vide Govt. of India consolidated order No-40-3/2020-DM-1 (A) Date-24/03/2020 and further modified dated-25/03/2020, 27/03/2020, 02/04/2020, 03/04/2020 and 10/04/2020 for complete restriction measure. As such the above persons violated the order during this pandemic situation duly promulgated by Govt. vide Order No- 40-3/2020-DM=1(A), GOI, MHA, 30th May 2020.

After that I reached at PS. On arrival at PS I type this letter of complaint at our PS computer and submitted to I.C Barabazar through duty officer SI Sajal Kanti Panda for taking necessary action as per law. I handed over all the relevant papers.
