Sir,

In producing here with one tractor attached with trolley bearing Registration No- WB-55A/9032 loaded with stone about 100 CFT, , Seizure list, Alamat and sample of Alamat as exhibit A; I beg to state that today on 26/06/2020 myself along with C/665 Rabindranath Gorai and C/1130 Asik Ansary performing mobile duty vide CC No-2028/2020 dt 26/06/2020 and GDE No-1589 dt 26/06/2020 with Govt vehicle bearing Registration No- WB 26 K 5475. I was carrying normal investigation kit box with me.

During mobile duty at Sankari more at about 13.15 hrs received source information about extracting and transportation of stone with intend to sale to other destinations by illegal means from Gohomikucha side towards Barabazar under this PS jurisdiction.

I conveyed the same to I.C Barabazar and as per his direction I along with force started Naka checking at Herbona from 14.05 hrs. At about 14.35 hrs one tractor having registration No- WB-55A/9032 loaded with stone was coming toward the Naka point and seeing the police party the driver fled away after keeping the tractor beside the road at Herbona. Chased him but somehow he managed to escape. Seized the tractor attached with trolley loaded with stone about 100 Cft.

Held an enquiry about the matter and so far information collected it is crystal clear that the driver and the owner collected the stone by illegal means with intend to make unlawful profit by unlawful collection of stone by illegal manner through unauthorized extraction and removal of mines & minerals. By this way they committed theft of minerals.

Under the above facts and circumstances, I pray before you that kindly take needful action against the driver of the tractor.
