Sir,

In producing herewith one arrested accused driver namely Pintu Hoque S/O- Sirajul Hoque of H No. 03, RD No. 26, Noor Colony, Mango, Jakirnagar, PS- Azadnagar, East Singhbhum (JKD), along with one seized truck bearing No. JH05CR/9520, I, SI Manas Dutta do hereby lodge a complaint against the arrested accused driver to the effect that today 25.06.2020 at about 12.45 hrs while I along with C/662 Dhananjay Pandey & C/11 Asim Roy was performing anticrime Naka Checking duty at Burudih more on Manbazar-Bandwan road found one truck bearing Reg. No. JH05CR/9520 was coming from Bandwan side and proceeding towards Manbazar side in very high speed. Accordingly we put signal to the vehicle to stop, but the driver of the vehicle disobeyed our signal and recklessly tried to fled away and dashed with one guardrail resulting damage to the guardrail and the guardrail was ejected from the road to the roadside in such a manner, it may endanger human life / life of on duty Police persons. At the time of accident the wind shield and the right side window shield of the vehicle also got damaged. However after a small chase we were able to detain the said truck near Kumari more and asked the driver to produce his driving license and other related documents in respect of the vehicle but he could not produce any such document at that moment. As he damaged a guardrail which is a public property / Govt. property by driving the vehicle in very high speed and recklessly which may endanger human life, I arrested him issuing memo of arrest and seized the vehicle under proper seizure list in presence of Police witnesses and duly signed by them. As it was noon, there was none to stand as witness. Then I brought the arrested accused driver and the seized vehicle at PS.

I, therefore, request you to lodge a specific case against the arrested driver namely Pintu Hoque S/O- Sirajul Hoque of H No. 03, RD No. 26, Noor Colony, Mango, Jakirnagar, PS- Azadnagar, East Singhbhum (JKD) under proper sections of Law and to arrange for its investigation.
