I do hereby lodge my complaint empowered by the Electricity(Amendment) Act-2007 to the effect that Mamtaj Alam S/O Lt. Md. Unis of Telkalpara,PS-Purulia(T) has committed theft of electricity under section 135(1)(b) as detailed here under.

Today, i.e. on 15.12.2016 I, Sourav Lahiri (DE&SM), Sri Chinmoy Maity,SAE(E),Sri Tapan Kumar Rajwar,(L.M.), of Telkalpara CCC,WBSEDCL conducted a raid programme at about 2.00 P.M. to 2.30 P.M. at Telkalpara under Purulia(T) P.S.When our team entered to the domestic premises of Mamtaj Alam we found that he was enjoying electricity dishonestly by means of bypassing the energy meter by tampering the service cable and run Toto Rickshaw Battery Charger, thus WBSEDCL losses revenue .As theft of electricity was detected the tampered service wire disconnected & meter dismantled from the line and seized and seizure list prepared . The signature of local witnesses could not able to obtain due to refusal. The seized material labelled and packed in presence of the local witnesses.

Mamtaj Alam S/O Lt. Md. Unis of Telkalpara,PS-Purulia(T) has committed theft of electricity under section 135(1)(b) of the Electricity(Amendment) Act-2007.
