Enclosed letter of Sri Sourav Nayak, Sr. Manager (PS), EM-OPH, STPS which is referred above may kindly be perused. It has been reported therein that on 13.12.2016 at 08:30 hrs, the following materials were sighted opposite Time Office, STPS, after their recovery from the Plant premises, near the boundary wall adjacent to the Switch Yard, transported from their original position inside the Switch Yard in front of the OPH Staff Room and Switch Yard guard surveillance shed.

1. Aluminium Hollow pipe bus along with connecting hardware for 22 KV Switch Yard-4 pcs.
2. Aluminium Single core 185 sq.mm, XLPE 6.6 KV cable-4 pcs. Each approx. 50 mtr. Length.


It may be noted that the above materials were under Round-the-Clock surveillance by personnel engaged by M/s Unit Electric Works and, as reported by the on-duty maintenance team, the above materials were last sighted at their original position till around 19:00 hrs on 12.12.2016. The mentioned cables used by the various departments in the Plant were valued at approximately Rs. 2,50,000/- (Rupees Two Lac Fifty Thousand Only).

In view of the above you are requested to kindly take cognizance of this letter as FIR and take further necessary course of action as per law of the land to prevent damage to public property.


