and inspected his/her premises. During the inspection theft of electricity was detected i.e. by passing the energy meter i.e. U/S135(I) (b) was detected. The details of passing the arrangement was damage installation of the incoming wire and top 2 (two) piece of wire by which electricity directly flow to his house without energy registration in WBSEDCL energy meter.

From the above by-passing system he/she uses the following electrical equipments.

- ① Freeze (180W) - 01 nos;
- ② Electric fan (60W) - 02 nos;
- ③ Colour TV (100W) - 01 nos;
- ④ CFL (15W) - 03 nos.

Out of which I seized the following.

- i) 2x1 core PVC wire (By-pass wire) - of length 02 ft (approx)
- ii) Bulb with holder - 01 no.

Seizure list was prepared at the site and accused person refuse to sign/signed. The inspection team left the premises at 14:35 Hrs on 15/12/2016. The accused person has committed an offence U/S135(I) (b) of the electricity act.-2003 subsequently electricity (Amendment) act.- 2007.
