Sir,

I, ASI Sadhan Sinha Mahapatra (D/B-20/09/1970) S/o Lt. Aditya Sinha Mahapatra of Joypur PS in producing herewith arrested accused (i) Sentu @ Khagendranath Mahato (38) S/o Brindabon Mahato of Birra, PS-Patamda, Dist-Saraikella, Jharkhand, (ii) Md. Mister @ Md Sahanawaj (32) S/o Md Kaiser, , (iii) Md. Raju Khan @ Md Raju (40) S/o Do both are of Joypur Ansary Para, PS-Joypur, Dist-Purulia and seized articles 64 Kgs.100 gram Ganja in three big bags and 09 packets samples each containing 50 grams all are duly labeled & one vehicle registration No. WB77A/1044, do hereby lodged complaint against them and against driver of vehicle no. WB77A/1044 and one Ashok Kuiry, of Adityapur side, Jharkhand, whose details particulars could not be collected so far to the effect that today i.e. 15/12/16 at about 19:45 hrs while myself along with force vide CC No. 4430/16 dated 15/12/16 was performing anti crime petrol duty at Gunja More under this PS on Chas more Bokaro Pitch Road (NH-34) noticed one vehicle is coming from Chas more side and proceeding towards Bokaro side as it was coming in excessive speed, we stopped the vehicle with view to check it. In the mean time two persons including the driver are able to flee away from the vehicle. Then strong suspicion arises in our mind, then we able to detain aforesaid 03 (three) arrested persons along with their vehicle having registration WB77A/1044. On checking of the vehicle we noticed 03 big bags on the back seat of the said vehicle. On interrogation they stated they are going to Bokaro Side to sale Ganja, which are with them in to those bags on the back seat of their vehicle. As they are carrying GANJA as per provision of NDPS Act, 1985, I issued notice to them in written that we want to search them also their vehicle in presence of Executive Officer or Gazetted Officer. They give in written that we can search them in presence of Executive Officer or Gazetted Officer. Then I informed IC Joypur PS the fact also requested IC Joypur PS to come to spot with BDO Joypur and to remain present at the time of search. IC Joypur PS informed me that he is coming to the spot with BDO Joypur. Then I collected measuring / weighment instrument locally from the line hotel cum welding shop of one Megu @ Timeswar Mahato S/O- Rowsan Mahato of Gunja, PS- Joypur, Dist- Purulia. Then at 20.45 hours IC Joypur PS accompanied with BDO Joypur and other officer and men of Joypur PS reached at spot. After arrival of BDO Joypur and IC Joypur PS in their presence I started to conducted search and able to discover and recover 03 (three) bags Ganja from their exclusive possession which they kept concealed on the back seat of their vehicle. Then we measured each 03 (three) bags of Ganja which containing 21 kg 600 grams, 21 kg and 21 kgs 500 grams Ganja respectively. I asked them to produce valid license / authority for possession of such Ganja, but they unable to produce any paper / authority for their such possession & business. On further interrogation all of them confessed that they are jointly with conspiracy of absconding accd namely Ashoke Kuiry running such clandestine business since long after collecting the same from North Bengal and dispatching the same in high rate at Bokaro side. Then I collect 03 (three) samples containing 50 grams in each from each bag marking each sample as Sample-A1, A2, A3 & B1, B2, B3 & C1, C2 & C3 in

presence of police witnesses as though local people was gathered but on request none came forwarded to help police. Then I have to seized the recovered GANJA in 03 (three) bags including samples and involved vehicle No WB77A/1044 in presence of witnesses from the possession from aforesaid 3 (three) arrested accused persons after preparing a seizure list which is duly signed as well as by the witnesses as noted above also by the accused persons. I am to note here sample No 03 of each bag was handed over to the accused persons and as a token of acknowledged, they have signed on the seizure list. Hence as they are liable for prosecution under Section 20 (b) (i) / 29 NDPS Act, 1985. So after observing all formalities of arrest I, arrested them after preparing arrest memos and one copy of memo was handed over to them as a token of acknowledgement. I am to note here arrested accd. Md Mister @ Md Sahanawaj of Ansary Para PS Joypur Dist Purulia was arrested and Charge Sheeted in c/w Joypur PS Case No-46/06 dated 13/12/03 u/s 20 of NDPS Act, 1985.

I, therefore, pray before your kind honour to register a case against them under Sec. 20 (b) (i) / 29 NDPS Act, 1985 and to arrange its regular investigation.
