I SI Supratik Mondal of Adra P.S. do here by lodged a complaint against accd. namely Rakesh Verma (41) S/O Murli Verma of Kamalasthan, Adra, PS- Adra Dist-Purulia to the effect that today (13.12.16) at about 17:05 hrs I received a telephonic information from a reliable source that one Rakesh Verma (41) S/O Murli Verma of Kamalasthan, Adra, PS- Adra Dist-Purulia was stocked country spirit illegally and selling the same to hike price for his personal gain then I noted this information in GD vide Adra PS GD No- 534 dtd 13.12.16 then I informed O/C Adra PS and as per order of O/C Adra PS myself along with JC/ 572 Avijit Khan & JC/ 342 Kashinath Chakraborty rushed to the spot for raid by Govt vehicle . At about 17:35 hrs myself along with force reached at Kamalasthan and hold raid in the road side shop of Rakesh Verma and found that said Rakesh Verma selling liquor at his own shop and seeing the police party some person fled away and said Rakesh Verma tried to conceal himself but we are able to apprehend him and also detained him. I asked him to produce valid License or valid papers of selling country spirit but he failed to produce any valid license or documents for possessing /selling the same, So I arrested the above mentioned accused person informing the ground of arrest and seized the above mentioned articles after preparing proper seizure list duly sign by accd person and available witnesses.

Hence I there for pray that a specific case may kindly be started against arrested accd. Rakesh Verma (41) S/O Murli Verma of Kamalasthan, Adra, PS- Adra Dist-Purulia and arrange for its investigation.
