
In producing here with one arrested accd. namely Jagdish Hela @ Modha Hela (40 Yrs.) S/O Parma Hela of Vill- Arrah (Near Harijan School) PS- Adra Dist- Purulia along with following seized articles viz-

- 1) 18 Ltrs (Approx) of country spirit contained in a container
- 2) 200 grms (Approx) NISHADAL,
- 3) Eight pieces of Plastic glass
- 4) Sell proceed of Rs. 138/-

I SI Supratik Mondal of Adra P.S. do here by lodge a complaint against accd. Jagdish Hela @ Modha Hela (40 Yrs.) S/O Parma Hela of Vill- Arrah (Near Harijan School) PS- Adra Dist- Purulia to the effect that today (15.12.16) at about 14:15 hrs. in course of my day mobile duty I received a telephonic information from a reliable source that accd. Jagdish Hela @ Modha Hela (40 Yrs.) S/O Parma Hela of Vill- Arrah (Near Harijan School) PS- Adra Dist- Purulia stocked country spirit illegally and selling the same to hike price for his personal gain then I informed the matter to O/C Adra PS and as per order of O/C Adra PS myself along with JC/342 Kashinath Chakraborty & NVF/196 Fulchand Paramanik rushed to the spot for raid by Govt vehicle. At about 14:35 hrs myself along with force reached Road Side Jhupri of Lower Jhariadli, Adra and held raid in the Jhupri of Jagdish Hela @ Modha Hela (40 Yrs.) S/O Parma Hela of Vill- Arrah (Near Harijan School) PS- Adra Dist- Purulia and found that Jagdish Hela @ Modha Hel was mixing the country spirit, contained in 20 Ltr. Container, with some intoxicated substance (like white powder) having acrid smell which is likely to cause disability or death to human being, at his own Jhupri and seeing the police party some person fled away but police party anyhow managed to apprehend accd Jagdish Hela @ Modha Hela and detained him. I asked him about the white powder like substance and accordingly, detained Jagdish Hela @ Modha Hela recognized it as "NISHADAL"(approx 200 grms contained in a plastic) an intoxicated substance having acrid smell which is likely to cause disability or death to human being. So I arrested the above mentioned accused person maintaining all guidelines of the Apex Court of India & NHRC regarding arrest and seized the above mentioned articles after preparing proper seizure list duly signed by accd person and available witnesses.

Hence I therefore pray that a specific case may kindly be started under proper section of law against arrested accd. Jagdish Hela @ Modha Hela (40 Yrs.) S/O Parma Hela of Vill- Arrah (Near Harijan School) PS- Adra Dist- Purulia and arrange for its investigation.
