## To The Officer-in-Charge **Adra Police Station Purulia**

Sir

In producing here with one arrested accd. Namely Shiva Mukhi (26 Yrs.) S/O Basudeb Mukhi of Sevanagar, Adra, PS- Adra Dist- Purulia along with following seized articles viz-

- 1) 17Ltrs(Approx) of country spirit contained in a container
- 2) 250 grms(Approx) NISHADAL,
- 3) Eleven pieces of Plastic glass
- 4) Sell proceed of Rs. 158/-

I SI Supratik Mondal of Adra P.S. do here by lodge a complaint against accd. Shiva Mukhi (26 Yrs.) S/O Basudeb Mukhi of Sevanagar, Adra, PS- Adra Dist- Purulia to the effect that today (17.12.16) at about 18:15 hrs. in course of my anticrime evening mobile duty I received a telephonic information from a reliable source that accd. Shiva Mukhi (26 Yrs.) S/O Basudeb Mukhi of Sevanagar, Adra, PS- Adra Dist- Purulia stocked country spirit illegally and selling the same to hike price for his personal gain then I informed the matter to O/C Adra PS and as per order of O/C Adra PS myself along with JC/572 Ajoy Giri & JC/124 Avijit Khan rushed to the spot for raid by Govt vehicle . At about 18:45 hrs myself along with force reached Road Side Jhupri of Sevanagar (Near Durga Mondap), Adra and held raid in the Jhupri Shiva Mukhi (26 Yrs.) S/O Basudeb Mukhi of Sevanagar, Adra, PS- Adra Dist- Purulia and found that Shiva Mukhi was mixing the country spirit, contained in 20 Ltr. Container, with some intoxicated substance (like white powder) having acrid smell which is likely to cause disability or death to human being, at his own Jhupri and seeing the police party some person fled away but police party anyhow managed to apprehend accd. Shiva Mukhi and detained him. I asked him about the white powder like substance and accordingly, detained Shiva Mukhi recognized it as "NISHADAL" (approx 250 gms contained in a plastic) an intoxicated substance having acrid smell which is likely to cause disability or death to human being. So I arrested the above mentioned accused person maintaining all guidelines of the Apex Court of India & NHRC regarding arrest and seized the above mentioned articles after preparing proper seizure list duly signed by accd. person and available witnesses.

Hence I therefore pray that a specific case may kindly be started under proper section of law against arrested accd. Shiva Mukhi (26 Yrs.) S/O Basudeb Mukhi of Sevanagar, Adra, PS- Adra Dist- Purulia and arrange for its investigation.
