I do hereby lodge complaint empowered by enabling The Electricity Act-2003, subsequently Electricity (Amendment) Act-2007 to the effect that on 16/12/16 at 11:56 AM, Apinla Mukherjee was enjoying electricity unlawfully by hooking from nearest L.T.O.H line and due to this reason he has committed theft of electricity U/S 135 of The Electricity (amendment Act-2007).

Entered the premises of Apinla Mukherjee, S/o. H. Abalad Mukherjee

and inspected his/her premises. During inspection theft of electricity was detected i.e. he/she was using electricity dishonestly by drawing illegal hooking from the nearest L.T.O.H line of W.B.S.E.D.C.L. i.e. U/S 135 (I)(a) was detected.
