Dear Sir,

I do hereby lodge complaint empowered by enabling The Electricity Act-2003, subsequently Electricity (Amendment) Act-2007 to the effect that On 16.12.16 at 12.15 P.m Thumtu Mudi was using electricity unlawfully i.e. hooking from nearest L.T.O.H line and due to this reason he has committed theft of electricity U/S 135 of The Electricity (amendment Act-2007).
