Beg to state as under :-

1... That the injured Smt. Manju Gope w/o Madhu Gope is the mother of the complainant residing at Beldih village and the accused persons above named are also the resident of same village within P.S. Arsha and within the jurisdiction of this court.

2... That on 23.11. 2016 when the mother of the complainant was returning from the pond the accused persons above named armed with lathi, stick attacked the ~~ix~~ mother of the complainant at Kuli road in front of ~~b~~ the door of injured Manju Gope and assaulted her by lathi, stick etc. on head and other parts of the body. Said Manju Gope sustained head injury and when she fell down with bleeding injury the witness No. 3 and 5 rescued her.

3.... That the complainant was far away from the village and after getting information he came to his village and on 24. 11.2016 went to Police Station Arsha and reported the matter. The Police concerned suggested him to admit the injured in the Hospital and after recovery the case will be started. as there was no case was started against the accused persons above named the complainant lodged the petition before the P. D. Pundlic
