Most respectfully beg to state as follows:-

 That the complainant is a permanent resident of Village-Tunturi within P.S Baghmundi.

Received information of P.S on 28/12/16 at 10.05/11/16 and started Bookmunds P.S. Case no-99/16 Ot-28/12/16 US-342/379/323/34IPC.




2. That the complainant have his urgent need and necessity took loan of Rs. 1,00,000/= from the accused person and the same Rampada Kuiry accused no.1 obtained some signatures of the complainant over some blank papers. It was decided that the complainant should pay interest of Rs. 5000/= per month and accordingly the complainant used to pay interest to the accused persons but accused persons did not issue any money receipts.

- That in the absence of the complainant and without his knowledge the accused persons inscribed some writing in the said paper.
- That the Complainant took the loan in the month of October
   2014.
- 5. That on 07-09-2015 the aforesaid Rampada Kuiry demanded money from the Complainant by coming to his house and the Complainant politely told that he has been suffering from ailments such as high-blood pressure and other ailments, So he will pay the money and requested him to allow two months time but the said Rampada Kuiry and his men forcibly abducted the Complainant and confined him in the garden of the accused persons situated at village Tunturi. The said accused persons confined the Complainant whole night and thereafter released him and threatened him that if any information be lodged at P.S he will shoot the Complainant.









- 7. That the accused persons are desperate and dangerous persons and Accused No.1 is money lender by profession and due to the threats given by him the complainant has been compelled to take shelter in the house of S.D Gorain at Balarampur by leaving village Tunturi.
- 8. That though the Complainant told the accused persons that he will pay the balance amount by easy instalments but the accused No.1 and his son and others threatened him both physically and mentally by coming to his house, the said accused persons also threatened the family members of the complainant.
- 9. That the Complainant informed the matter at Officer-in-Charge Baghmundi P.S but as no step was taken by the O.C so the Complainant lodged written diary before Superintendent of Police, Purulia on 05-12-2016.
- 10. That on 05-12-2016 while the Complainant returning to his house at Balarampur from Purulia town, the said Rampada Kuiry and his son Janardan Kuiry suddenly came near the house of the Complainant with a motorcycle and they assaulted him by fist and blows and took Rs. 1500/= from the

pocket of the Complainant and also threatened the wife and son of the Complainant.

- 11. That it may be mentioned that the accused persons took all the original documents from the Complainant.
- 12. That the witnesses are aware of the incident committed by the accused persons.
- 13. That the accused persons have committed an offence punishable under Sections 340/379/323/34 of the I.P.C.

It is therefore prayed that your Honour would be pleased to direct the Officer-in-Charge Baghmundi P.S to start a case against the accused persons under Sections 340/379/323/34 of the I.P.C by treating this petition of complaint as F.I.R under Section 156(3) Cr.P.C.
