I do hereby lodge complaint empowered by enabling The Electricity Act-2003, subsequently Electricity (Amendment) Act-2007 to the effect that Nemai Mudi, S/o-Laxmikanta Mudi of village - Teleghana, P.S - Boro, was enjoying electricity unauthorizely for construction purpose by hooking from the nearest L.T.O.H line. i.e. he has committed theft of electricity U/S 135 of The Electricity (amendment Act-2007).
