I SI Aditya Prasad Banerjee, O/C Hura PS do hereby lodged a complaint as suo motto to the effect that election and counting of votes for formation of new student Union of M.G. College, Lalpur was being held today i.e. on 23.12.16 from 11.00 hrs. with a view to avoid any untoward incident over this election process, Additional District Magistrate, Purulia had promulgated prohibitory order U/S-144 Cr.P.C. vide his Memo No- 1187(12)/J Dtd- 22.12.16, prohibiting assembly of five or more persons within the radius of 200 mtrs. from M.G. College Lalpur campus i.e. Venue of election w.e.f. 07.00 hrs. on 23.12.16 till completion of election process. Accordingly public announcement was done throughout the day, in the area to make all concerned aware of the said prohibitory order promulgated U/S- 144 Cr.P.C. Necessary police arrangement was put in the place to prevent any breach of peace and untoward incident over the said election process and to enforce the said prohibitory order U/S- 144 Cr.P.C. At around 16.00 hrs., today (i.e. on 23.12.16) after 15 mtrs. from Lalpur Community Hall toward Hura PS on the left side of NH60A which was well within 100 mtrs. From the venue of election i.e. M.G. College Lalpur an agitated & furious mob of 20/25 persons gathered and was approaching towards the M.G. College Campus with suspicious motive. Seen the agitated mob approaching to the venue, the mob was inform that prohibitory order U/S- 144 Cr.P.C. was enforce and their assembly has turned into unlawful assembly for violation of the order U/S- 144 Cr.P.C. They were warned to disperse immediately or else force would be applied. They did not pay any heed to the warning. As a result minimum force was applied to disperse the said mob. Immediately they disperse and none could be arrested or identified. As the aforesaid person committed offence u/s- 143/188 IPC. On returning to PS I lodged Hura PS Case No- 119/16 Dtd- 23.12.16, u/s- 143/188 IPC as suo-motto against unknown 20/25 members of unlawful assembly and directed to SI Mithun Kr. Sar to investigate the matter.
