Entered the premises of MD. Rizuddin Ansari, s/o Md. Daulat Ansari vill - Higuli p.s - Hura Dist - Purulia

inspected his/her premises. During inspection theft of electricity was detected i.e. he/ she was using electricity dishonestly by taping the incoming cable of the energy meter installed in his/her premises and therefore bypassing the energy meter of W.B.S.E.D.C.L. i.e. U/S 135 (I) (b) was detected.

From the above arrangement he/ she was using the following electrical equipments

- 1) Bulb - 01 No with holder of 100 watt.
- 2) one no fan ceiling - 1 no = 100 watt
- 3) Tele vision - 1 no = 60 watt

out of which I seized the following

- 1) One no energy meter with P.P. Box, make TTL LTD. sl.no - TS259903
