and inspected his/her premises. During inspection theft of electricity was detected i.e. he/ she was using electricity dishonestly by taping the incoming cable of the energy meter installed in his/her premises and therefore bypassing the energy meter of W.B.S.E.D.C.L. i.e. U/S 135 (I) (b) was detected.

From the above arrangement he/ she was using the following electrical equipments

- 2) one no fan ceiling - 1 No - 100 watt
