In producing here with 02 (Two) arrested accused person namely (i) Badal Chandra (35) S/O Paritosh Chandra of Jhalda Ward No- VIII, P.S- Jhalda, Dist- Purulia (ii) Sanjib Koyal (37) S/O Mathan Koyal of Jhalda Ward no- IX, P.S- Jhalda, Dist- Purulia and brought under seizure the following article; (1) 01 (one) black colour school bag containing with 20 (Twenty) bottles of PHENCYREX Cough Syrup 100 ml. each (Chlorpheniramine Maleate & Codine Phosphate Syrup) of M & B PHARMACEUTICALS Ltd. Batch No.- 06055-MB2 Exp date- April. 2017. (2) 01 (one) lylen bag containing with 16 (Sixteen) bottles of PHENCYREX Cough Syrup 100 ml. each (Chlorpheniramine Maleate & Codine Phosphate Syrup) of M & B PHARMACEUTICALS Ltd. Batch No.- 06055-MB2 Exp date- April. 2017. I do here by lodged a written complaint against the above noted accused persons to the effect that today (24/12/16) at 21:15 hrs. during my evening Mobile duty I received a telephonic information from my source that 02 (Two) persons coming from Jhalda station proceeded to Jhalda Poddarpara on Garkuli road with huge quantities of drugs with them. After received such type of information myself along with force namely C/797- Chandi Charan Raja C/380- Ajoy Krishna Roy and C/403- Kirity Charan Mahato who were performing evening mobile duty rushed to Garkuli Road and keep our vehicle in a dark place. We wait for few times at near school and at 21:25 hrs we found two persons coming from Jhalda station para and going towards Jhalda town. On seeing the Police party they tried to flee away after hot chasing we managed to apprehended two person. After apprehended I asked their identity they disclosed their name and address as noted in above. On being search them 01 (one) black colour school bag containing with 20 (Twenty) bottles of PHENCYREX Cough Syrup 100 ml. each (Chlorpheniramine Maleate & Codine Phosphate Syrup) of M & B PHARMACEUTICALS Ltd. Batch No.- 06055-MB2 Exp date- April 2017 from the exclusive possessions of accd. Badal Chandra and 01 (one) lylen bag containing with 16 (Sixteen) bottles of PHENCYREX Cough Syrup 100 ml. each (Chlorpheniramine Maleate & Codine Phosphate Syrup) of M & B PHARMACEUTICALS Ltd. Batch No.- 06055-MB2 Exp date- April. 2017 from the exclusive possession of Sanjib Koyal. On demand they failed to produce any valid documents/ license in respect of keeping the said drugs. So I seized the same and prepare proper seizure list duly signed by the witnesses as well as the apprehended persons and also prepared label with seal two bottles of PHENCYREX Cough Syrup as sample. I arrested the said accused persons for violating the sec. 27 of drugs and cosmetic act 1940 after issuing arrest memo and inspection memo. During arrest observe all the formalities regarding the guideline WBHRC, NHRC and Hon'ble Apex Court of India.

I therefore pray before you to start a case against the above noted arrested accused persons namely (i) Badal Chandra (35) S/O Paritosh Chandra of Jhalda Ward No- VIII, P.S- Jhalda, Dist- Purulia (ii) Sanjib Koyal (37) S/O Mathan Koyal of Jhalda Ward no- IX, P.S- Jhalda, Dist- Purulia per law and arranged for its investigation.
