
In producing herewith arrested accused namely Susanta Mandal(26 yrs), S/O- Tapan Mandal of vill- Lohat, PS -Kashipur, Dist- Purulia along with seize articles, I beg to report that on 17/12/16 in course of mobile duty myself along with force got reliable source information that one person is selling country liquor at village Lohat in his grocery shop under Kashipur PS. To work out the information I SI Abhijit Singha along with JC/299 Swadesh Satpati, JC/977 Tarun Kadam, reached at Lohat village at about 18:35 hrs and found that one person was selling C.S.liquor in his grocery shop. After seeing police party liquor customers fled away from the spot. On demand the seller failed to produce any valid document for selling C.S. liquor in his possession. So the above noted accused has committed an offence u/s-46(A)(c) B.E. Act 1909 Amended up-to date. During search I found (1)107 (One hundred and seven) sealed bottles of DILSE C.S. liquor (600 ml) @Rs. 25/-(Twenty five) each in per bottle blended and bottled by Singh Fisher.N vill- Kalipur, P.O- Simulia, PS- Purulia(M), Dist-Purulia, which is amount total Rs. 2675/ (Two thousand six hundred seventy five) only (2) 05 (Five) empty bottles of DIL SE C.S .(3) 04(Four) Tea Glass (4) Rs.200/-(Two hundred) as sale proceed seized the above noted articles under proper seizure list duly signed by the witnesses in between 18:45 hrs. to 19:05 hrs. I also seized and labeled bottles with sample C.S. liquor at the spot in presence of accused person and witnesses . Accordingly I arrested the above noted accused person u/s-67 Bengal Excise Act 1909 and informing him the ground of arrest and I prepared arrest memo after maintaining all arresting rule as well as I brought him to P.S. with seized above noted articles.

Therefore I pray before you that kindly arrange to start a specific case under proper section of law u/s 46(A)(c) B.E. Act 1909 against arrested accused Susanta Mandal(26 yrs), S/O- Tapan Mandal of vill- Lohat, PS -Kashipur, Dist- Purulia and arrange for its investigation.
