

In producing here with one arrested accd namely Mahananda Majhi (64), S/O - Lt Rahani Kanta Majhi of village Gamarkuri, PS- Kashipur, Dist- Purulia along with following seized articles Viz-

- 1) 20 Liters (Approx) of country spirit contained in a plastic container
- 2) 200 grams (Approx) NISHADAL,
- 3) Five pieces of glass &
- 4) Sale proceed of Rs. 240/--

I ASI Indrajit Sarkar of Kashipur P.S. do here by lodged a complaint against aced. Mahananda Majhi (64), S/O - Lt Rahani Kanta Majhi of village Gamarkuri, PS- Kashipur, Dist-Purulia to the effect that today (22/12/16) at about 17.25 hrs in course of mobile duty I received a telephonic information from a reliable source that accd. Mahananda Majhi (64), S/O - Lt Rahani Kanta Majhi of village Gamarkuri, PS- Kashipur, Dist- Purulia stocked country spirit illegally at his house at Gamarkuri and selling the same to hike price for his personal gain. I informed the matter to O/C Kashipur PS and as per order of O/C Kashipur PS myself along with C/1287 Om Prakash Sharma and JC/977 Tarun Kadam both of Kashipur PS rushed to the spot for raid by Govt vehicle. At about 18.05 hrs myself along with force reached at Gamarkuri and held raid in the house of Mahananda Majhi (64), S/O - Lt Rahani Kanta Majhi of village Gamarkuri, PS- Kashipur, Dist-Purulia and found that Mahananda Majhi was mixing the country spirit, contained in plastic Container, with some intoxicated substance (like white powder) having acrid smell which is likely to cause disability or death to human being, at his own house at Gamarkuri and seeing the police party some person fled away but police party any how managed to apprehend accd Mahananda Majhi, and detained him. I asked him about the white powder like substance and accordingly. detained Mahananda Majhi recognized it as "NISHADAL" (approx 200 gms contained in a plastic) an intoxicated substance having acrid smell which is likely to cause disability or death to human being. So I arrested the above mentioned accused person informing the ground of arrest and seized the above mentioned articles after preparing proper seizure list duly sign by accd person and available witnesses and also sealed and labeled the same.

Hence I therefore pray that a specific case may kindly be started under proper section of law against arrested accd. Mahananda Majhi (64), S/O - Lt Rahani Kanta Majhi of village Gamarkuri, PS- Kashipur, Dist-Purulia and arrange for its investigation.
