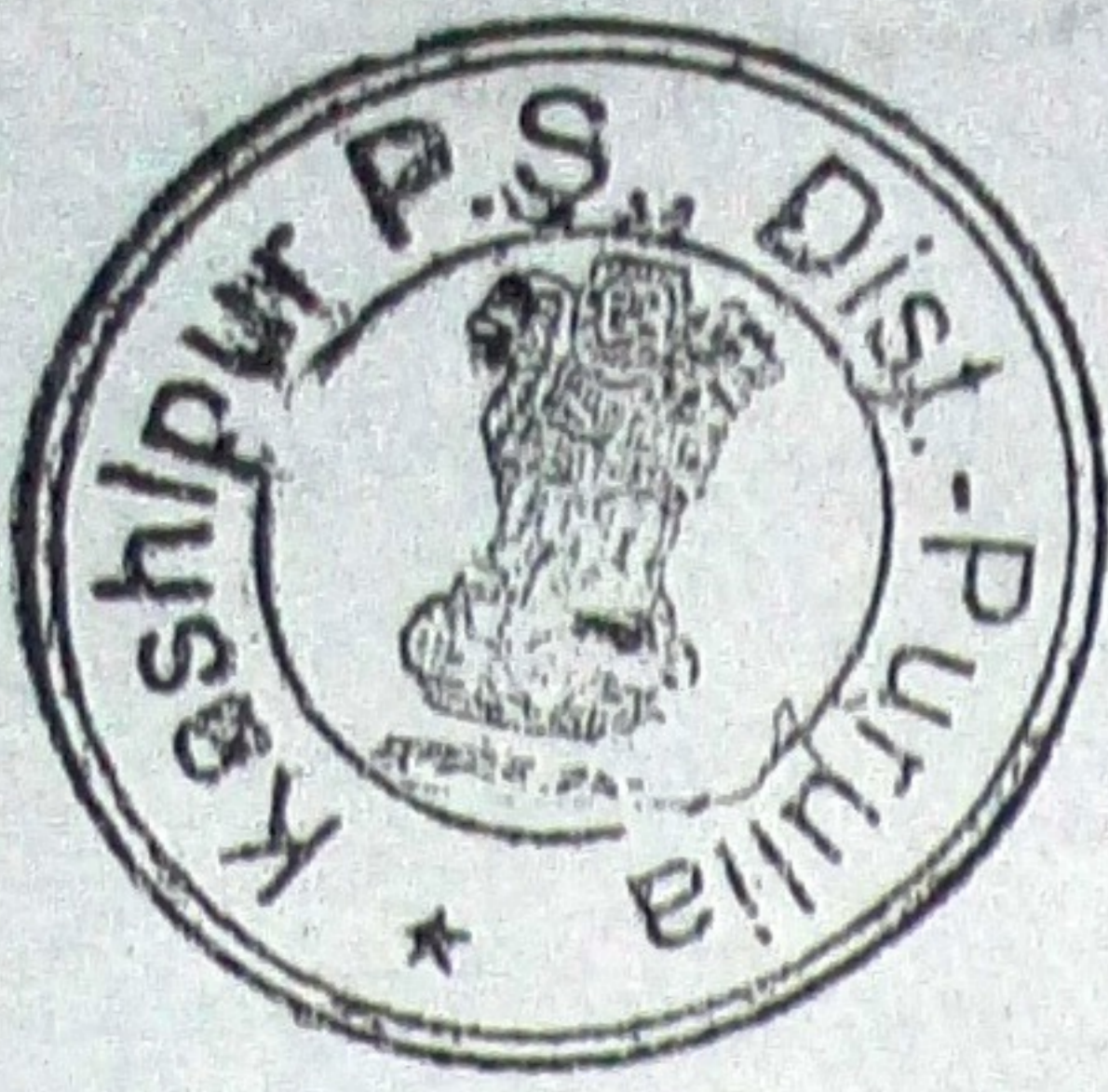

Dear Sir,

I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that, Sri Jitan Bouri, S/O Gurupada Bouri, Vill- Kashipur(Loharpara), PO-PK RAJ., PS- Kashipur Dist- Purulia for theft of energy by means of Bye passing the Meter by illegal way and by damage the terminal cover seal, by means of a wire fitted with incoming side of meter of WBSEDCL.

On dated 24.12.2016 at about 11.10 am myself alongwith Sri Dipak Kr. Bhowmik, SAE, and Sri Shyamal Chatterjee HG, SRLM went to supervisory reading to the consumer premices at Loharpar, Kashipur. During inspection of the premices of jiten Bouri, S/O Gurupada Bouri it was found that Sri Jiten Bouri using electricity dishonestly by means by broken of seal(no-XG8100057) from terminal cover for low registration of meter. For that illegal activity we disconnect his connection con no-202148655 in the name of Jitan Bouri, and con no- 242077004 and seized the wire wich was use for by passing length 12 mt. then we left the premices at 11.40 am after preparation of proper seizure list at site.

Total Load found approx 0.5 KW (Fan-3 Bulb-2, CFL-2, TV-1 no)

Then we disconnect his line and his permanent connection also ,seized the following articles.

- 1) Wire used for bye passing-12 mt.
- 2) Bulb with holder---1no

after preparation of proper seizure list. The seizure list are prepared at the site and the representative of accused person refuse to sign in the seizer list. The inspection team left the above premises at about 11.40am. The accused person has committed an offence U/S-135(i)(a)(b) of the Electricity (Amendment) Act-2007 for illegal theft of electricity.

You are requested to take cognizance of the complaint and treat it as F.I.R and action may be taken as per rule.
