Most respectfully begs to state:

1. That the Complainant, Accused Persons No.1 & 2 and the Witnesses No.2 to 5 are the permanent resident of Village Tatuara having their residential houses therein.

2. That on 02/09/2016 at about 10 P.M. the Accused Persons along with some other persons by forming an unlawful assembly suddenly entered into the house of the Complainant with some deadly weapons and assaulted the Complainant.

3. That the Accused persons have damaged the household articles of the Complainant and took away about Rs.12,000/- cash and some golden and silver ornaments after breaking a box forcefully.
4. That the Complainant and the Witness No.2 & 3 made protest against such illegal work of the Accused Persons but the Accused Person putting them under fear by showing the deadly weapons and threatened them with dire consequences if they raised hue and cry.
5. That at that time the Complainant and others raised hue and cry and on hearing the same the neighbors came to the place of incident and on seeing them the Accused Persons fled away.
6. That the Accused Persons left the place after taking away the cash and golden and silver ornaments of the Complainant. The Complainant due to such assault sustained some injuries on his persons and for that he suffered bodily pain for several days.
7. That thereafter the Complainant went to Kotshila P.S. on 03/09/2016 and informed the matter to the O/C Kotshila P.S. but the Police did not take any action.
8. That the Complainant thereafter on several occasions met the O/C Kotshila P.S. inquiring about the steps taken by him against the Accused Persons but the police did not take any action in the matter up-till now.
9. That the Complainant also informed the matter to the S.P. Purulia but up-till now no action has been taken by the police.
10. That thus the Complainant brought this case for the offences committed by the Accused Persons for which they are liable to be prosecuted.

It is therefore prayed that your honour may graciously be pleased to treat this petition as a Complaint under Section-156(3) of the Cr.P.C. & send the petition to the O/C Kotshila P.S. for investigation & further be pleased to pass necessary order
