Kastik Mandi of Kapasra Tola, was enjoying electricity unauthorizedly by illegal hooking from nearest LT overhead line and he has committed theft of electricity U/S 135 of the electricity (Amendment act-2007).

Entered into the premises of Shri Kalipada Mandi S/O Lt. Kastik Mandi and inspected his premises at Vill- Kapasra Tola P.O. Moheta, P.S- Manbazar, DIST- PURULIA.

During inspection, it was found that Shri Kalipada Mandi S/O Lt. Kastik Mandi of Kapasra Tola, was enjoying electricity illegally by using direct hooking from the nearest LT overhead line in his premises at Kapasra Tola with the help of Flexible PVC 2 Core (10mts) having connected load 0.2 KW. The user fled away from the site at Kapasra Tola, on 20/12/16 at 12:15 PM

From the above arrangement he was using the following equipment :

01. 02 Nos Lamp (100 W each)
02. Switch Board with Holder.
03. Flexible PVC 2 Core (10 mts, approx.) with Hooking device.

Out of which I seized the following articles:

1. 01 No Lamp (100W), with switch board and holder.
2. Flexible PVC 2 Core (10 mts, approx.) with Hooking device.

Seizure list was prepared at site and accused person was fled away. After process of inspection and seizure list we left the premises at about 12:20 PM

The said person has committed an offence U/S 135(1)(a) of electricity act 2003 subsequently electricity (Amendment) act-2007.
