I do hereby lodge my complaint empowered by the Electricity(Amendment) Act-2007 to the effect that Sri Sukumar Pandey S/O Lt. Harendranath Pandey of Vill-Kanali, PS-Purulia(M) has committed theft of electricity under section 135(1)(a) as detailed here under.

Today, i.e. on 24.12.2016 I, Prashant Kishor (AE&SM), along with Sri Debdas Bhattacharjee, Sr.SAE(E) S/O Sri Murlidhar Bhattacharjee & Sri Chinmoy Maity,SAE(E) S/O Sri Pradip Kumar Maity of Telkalpara CCC, WBSEDCL conducted a raid programme. at village Kanali under Purulia(M) P.S. When our team at about 12.15 P.M entered to the Domestic premises of Sri Sukumar Pandey, we found that he was enjoying electricity dishonestly by means of direct hooking from nearest LTOH line and run heater in kitchen and domestic appliances, thus WBSEDCL losses revenue .As theft of electricity was detected in presence of the local witnesses, at first disconnected the wire with hooking arrangement from LTOH line and seized and seizure list prepared .The seized material labeled in presence of the local witnesses. The inspection team left the aforesaid location at about 12.45 P.M after completion of inspection & necessary formalities.

Sri Sukumar Pandey S/O Lt. Harendranath Pandey of Vill-Kanali,PS-Purulia(M) has committed theft of electricity under section 135(1)(a) of the Electricity(Amendment) Act-2007.

You are requested to take cognizance of this complain & treat it as FIR


