Today, i.e. on 26.12.2016 I, Prashant Kishor ,AE& S.M.,along with Sri Sankar Ch. Mahato,LM,Sri Gour Ch. Mahato,Gr-1 Sr.TSH,Sri Amarendra Mahato,Gr.-1 Sr.TSH of S&LP Unit ,Purulia Regional Office, & Sri Chinmoy Maity,SAE(E),Telkalpara CCC of WBSEDCL conducted a raid programme at about 12.00 P.M. to 12.30 P.M. at Chirumarcha village under Purulia(M) P.S. When our team entered to the domestic premises of Sri Radha Krishna Mahato, we found that he was enjoying electricity dishonestly by means of direct hooking from nearest LTOH line and run domestic appliances, thus WBSEDCL losses revenue .As theft of electricity was detected in presence of the local witnesses the hooking wire dismantled and seized and seizure list prepare . The signature of the accused and local witnesses could not able to obtain due to refusal. The seized material labelled in presence of the local witnesses.

Sri Radha Krishna Mahato S/O Lt.Pandav Mahato of Vill-Chirumarcha, P.O.-Banbaligara, PS-Purulia(M) has committed theft of electricity under section 135(1)(a) of the Electricity(Amendment) Act-2007.
