The humble complaint on behalf of the complainant:-

Most respectfully sheweth:-

1. That, the complainant is a permanent resident of village Baligara, within P.S. Purulia(M), Dist.Purulia.
2. That, one Pond which is situated southern side of the Baligara village locally known as 'Ajubandh' and the village people used to take bath in the said 'Bandh' and the complainant and other co-sharers are the actual owners of the said 'Bandh'.
3. That, prior to the occurrence the accused persons were creating much disturbance over the issue of the said pond and for which they gave some threatening to the complainant and his other co-sharers without any just and proper reasons and a pandimonium has created by the accused persons over the issue of the said Pond and for which the complainant became perplexed about the role of the accused persons.
4. That on 03.10.16 all the accused persons with some malafide intention without taking any permission from the complainant and other co-sharers cut down the Ail of the said Pond and some fishes came out from the said

Pond and for which the entire water of the said Pond with some fishes came out to the said cutting portion and the same was stored without nearby paddy field. The complainant and other witnesses when came to know about the illegal acts of the accused persons raises strong objection and the accused persons became furious and ultimatum was given that they would give a good lesson to the complainant party whenever opportunity will get and in such a way the complainant and other persons became panicky about the threatening given by the accused persons.

5. That, on 04.10.16 about 10.00 a.m. when while Sonapada Gope son of Durgacharan Gope was sitting to the house of Dukhu Gope on his door step, suddenly all the accused persons being armed with deadly weapons formed a wrongful assembly near the door step of Dukhu Gope and started filthy languages aiming towards Sonapada Gope and other witnesses who were remained present near the house of Dukhu Gope, suddenly the wrongful assembly became furious and in a most aggressive way with pre-planned with some common intention attacked Sonapada Gope and accused Tapan Gope son of Dukhan Gope gave a Lathi Blow upon Sonapada Gope on his ~~eye~~ head and also various of his body as per direct assistance and instigation of the

other accused persons and the injured Sonapada Gope received grievous injury on his head and he ~~failed~~ fell down on the ground in bleeding condition. One Khepu Gope son of Sitaram Gope and other witnesses who were remained present at the time of incident immediately in order to save Sonapada Gope but one Shaktipada Gope son of Dukhan Gope assaulted him by Tangi on his head and other of the body and he also received injury. The conduct and the aggressive nature all the accused persons and their common intention and common object would indicate that there was intention on their part to kill Sonapada Gope and Khepu Gope to finish their life.

6. That, the entire incident were witnessed by the witnesses and some other villagers also but due to aggressive conduct of the accused persons no-body came forward or to do anything. However thereafter the injured persons namely Sonapada Gope and Khepu Gope were shifted to Purulia sadar Hospital for their treatment and as the condition of Sonapada Gope was in a precarious condition he was referred to Rajendra Institute of Medical Science at Ranchi and he was treated at the said Hospital from 07.10.16 to 11.10.16 with head Injury.

7. That, the matter was brought to the notice to the Purulia (M) P.S. on 04.10.16 and the Police officer assured the complainant and also advised to take proper care of the injured persons for their treatment and a legal action would be taken against the accused persons in proper section of law but curiously the Police officer instead of started a specific case against the accused persons had initiated a proceeding U/S 107 Cr.P.C. against the complainant and the accused persons. In spite of that the complainant visited on a number of occasions and met with the O/C Purulia (M) P.S. about the fate of the information which was given on 04.10.16 but no fruitful result has yet been received by the complainant and the matter was also brought to the notice Superintendent of Police Purulia on 25.10.16 but no specific case has yet been started and accordingly there has been a delay in filing this complaint and the complainant has able to make out a satisfactory explanation in delay in lodging the complaint. The complainant is now filing the present case against the accused persons before your Honour's Court with a prayer to send the said complaint to the concerned P.S. of Purulia (M) P.S. for causing investigation after treating the same as F.I.R. The complainant
