Sub: Request for lodging F.I.R. against arrested accused Shyama Orang (28yrs) 8/O – Mahadev Orang of Sarbagan, Orang Para, Ward No- 22, PS- Purulia (T), Dist- Purulia u/s- 46A of B.E. Act 1909.

Sir,

In producing herewith one arrested accused person Shvama Orang (28vrs) S/O - Mahadeb Orang of Sarbagan, Orang Para, Ward No- 22, PS- Purulia (T), Dist- Purulia under Arrest Memo, Inspection Memo alongwith seized articles viz. (i) 35 (thirty five) bottles of Country Spirit designed as 'Dil Se' (each bottle contains 600ml of country spirit having strength 800 UP being sealed properly). (ii) one black coloured plastic jarican having approximate 21 Ltrs. Of ID liquor, (iii) one bottle of 'Dil Se' as sample of Sl. No. (i). (iv) one bottle of ID Liquor (01 ltr.) as sample of Sl. No. (ii), (v) 12 (twelve) plastic glasses, under proper seizure list and being labeled properly, I beg to report that today at 17:25 hrs. SLP.P. Chakraborty, Duty Officer of Purulia (T) PS received a telephonic information that one person namely Shyama Orang (28yrs) S/O - Mahadeb Orang of Sarbagan, Orang Para, Ward No-22. PS- Purulia (T). Dist- Purulia is selling ID liquor and country spirit at Orang Para illegally, Accordingly he informed the matter to O/C Purulia (T) PS and as per direction of O/C Purulia (T) PS he directed me to work out the information. Accordingly myself alongwith force reached at Orang Para and keeping the vehicle at a reasonable distance we proceeded to the house of Shyama Orang s/o-Mahadeb Orang as being shown by the source from distance. We entered in the house of Shyama Orang (28yrs) and found one person was selling ID liquor and some persons were drinking in the courtyard of the house. Seeing the police all persons fled away leaving some plastic glasses but however we could apprehend the seller of the Country Spirit and ID Liquor. On searching the house we recover 35 (Thirty Five) bottles of 'Dil Se', 01 (one) plastic jarican each of them contains 21 ltrs (approx) of ID liquor. On being interrogated the youth revealed his identity as Shyama Orang (28yrs) S/O - Mahadeb Orang of Sarbagan, Orang Para, Ward No- 22, PS- Purulia (T), Dist- Purulia, On asked he could not produce any license in favour of selling, keeping or possessing ID liquor or country spirit. Accordingly I seized 35 (thirty five) bottles of 'Dil Se', 01 (one) plastic jarican containing 21 Itrs (approx) of ID liquor and 12 (twelve) plastic glasses from his possession after labeling and sealed properly and took sample of each of the items and arrested him observing all the formalities regarding arrest as his offence comes under the ambit of 46(A) (c) of B.F. Act 1909.

Hence a specific case may kindly be started and arrange for its investigation.
