

The Complainant above named

Most respectfully begs to state as follows:-

- That the complainant is a resident of Amdiha and deals in milk business.
- That the accused persons are land broker by occupation. Accused no.1 has got lands at Mouza – Nadiha under Purulia town Police station and Purulia (M) Police station.
- 3. That the complainant has been running his khatal in the land left by Sanat Kumar Mitra, father of the complainant and the complainant used to pay money to the accused from time to time. Accused no. 1 also used to get cow-dung from the Khatal of the complainant.
- That as the complainant has been running his Khatal in the land of father of accused no.1 so there was / is a good intimacy amongst them.
- That the accused no.1 was in need of money and accordingly accused came down at Purulia and requested the complainant to sell his property situated at Mouza – Nadiha.
- 6. That due to existence of good relationship the complainant told accused no.1 that without Power of Attorney it is not possible on his part to sell or to dispose of the property.
- That accused no.1 demanded money from the complainant to meet his needs.
- That the aforesaid accused no.1 voluntarily executed a registered
   Power of Attorney in favour of the complainant empowering him to



sell the land on his behalf.

- 9. That the complainant collected money from prospective purchasers and he had some money at his house and handed over a sum of Rs. 20,00,000/- (Rupees Twenty Lac) to accused no.1 and the aforesaid accused executed a money receipt in favour of the complainant on 03-09-2015 by putting his signature over a Non-Judicial stamp Papar of value Rs. 10/-, one of the men of accused no.1 namely Debu Dutta also put his signature. Accused no.2 was all along present at the time of talk and payment of money because he is a trusted person of accused no.1.
- 10. That Power of Attorney has been executed in respect of R.S. Plot no. 993, 3773, 2100 and 2112.
- 11. That after receiving the said money accused no.1 kept mum and thereafter again demanded some more money from the complainant and the complainant told that he will pay the remaining amount after executing the deeds.
- 12. That the accused persons on the plea of seeing the original documents took away the original Power of Attorney and the money receipts and ultimately the accused persons in collusion ad concert! with each other cheated/ deceived the complainant though accused no.1 took Rs. 20,00,000/- (Rupees twenty Lacs) from the complainant.
- 13. That the accused persons defrauded the complainant and cunningly received Rs. 20,00,000/- (Rupees twenty Lacs).



- 14. That the accused persons with a view to create pressure upon the complainant has revoked the Power of Attorney though the complainant sold the property to other persons.
- 15. That the prospective purchasers are also giving threats and the accused persons who are very influential are also giving threats to the complainant and his family members.
- 16. That the accused persons have cunningly took away the original Power of Attorney and the money receipt for their wrongful gain and they have also caused wrongful loss to the complainant by receiving Rs. 20,00,000/- (Rupees twenty Lacs).
- 17. That the complainant orally informed the matter at Purulia town police station and thereafter lodged complaint to Superintendent of Police Purulia on 28-11-2016 but no step has been taken by the Police in this matter and for that reason the complainant has filed this petition with a prayer for taking necessary action in the matter.

It is therefore prayed that your Honour may be graciously be pleased to treat this petition as complaint and send same to the Officer-in-Charge Purulia (town) Police station with a direction to investigate in the matter as per provision of the Section 156(3) Cr.P.C. and further be pleased to pass necessary orders.
