Santaldih, Dist. Purulia to the effect that today (15/12/16)
at around 21.20 (PM) I was discharging my govt duty
at Santaldih P.S., by that time I noticed that approx
20-25 men forcibly entered inside the P.S. compound
violating the direction of sentry constable on duty
namely C-793 Mohandas Murmu and damaging the main
gate. Myself alongwith SI A.K. Mishra, ASI B. Panda
and some other officers and men tried to resist the
to maintain security of the P.S. and asked them
identity and purpose. But they became more
violent and started to threaten me and other
Police personnel for not starting a case against
them over the incident of assaulting workers of
TATA company at Paradi on today. They also threatened
us saying not to do any action against the
accused persons. They started to act more
violently by pelting brick, bats, attacked us
with bamboo and bricks with a view to assault
Police personnel and cause grievous injury.

As a result myself alongwith ASI Loumen
Panda sustained bleeding injury on our persons.
They assaulted Police personnel to deter us from
discharge of govt duty. On the above circum-
stances I with the help of my accompanying
officers and force arrested 08 persons from them
while some others fled away towards Kanai Bazar.
The arrested persons disclosed their identities
as noted in sl no (1) to (8). I observed all legal
rules of arrest. I came to know that the above
noted accused persons committed such illegal act
for registering a case against them vide the
P.S. case NO 58/16 dt 15/12/16.

So I started this case as suo motu against
the noted accused persons for committing an
offence u/s 147/148/149/447/353/323/325/338/427/5
IPC, 314 PDPP Act and directed SI M. Manna
for its investigation.
