The complainant above named;
Most respectfully beg to state as follows:-

1. That the complainant is a resident of Village- Kuwardih within P.S Hura.
2. That the complainant and his brother have got a Tank (Bandh) bearing R.S Plot No.519 recorded in L.R Khatian No.280/1, 68/1, 470/1, the said tank is locally known as Robi Mondal Bandh. The complainant is son of Robi Mondal.
3. That the complainant and his brother are in possession of the Tank by rearing and catching fishes and there are good number of fishes therein. The complainant and his brother planted various trees on the ail of the Tank such as Sonaijhuri, Nim, Mango, Palash, Khejur black berry etc.
4. That on the date of occurrence i.e on 29-12-2016 the aforesaid accused persons without any right whatsoever with a view to obtain wrongful gain and with a view to cause wrongful loss to the complainant criminally trespassed into R.S Plot No.519 i.e on the ail of the Tank armed with weapons such as Dauli, Daa, Axe, Lathi etc at about 9.00 a.m and they began to cut tree standing in the ail planted by the complainant and his brother.
5. That the complainant was going to the Tank for bathing and he saw the accused persons to cut his trees and the complainant by seeing the accused persons raised protest, that at that time

accused Mihir Mondal ordered the other accused to finish the life of the complainant and after getting the order Trilochan, Prahalla and Pandulal Mondal with their Dauli (Kantari) struck the head of the complainant and face and by the said assault 2 teeth of the lower part of the complainant have broken and blood was oozing out from the nose of the complainant. Mihir Mondal and other persons also assaulted the complainant with Lathi and other weapons. That the accused persons with a view to finish the life of the complainant attacked him and assaulted him with Dauli over his head and face. The accused persons also cut the 5 trees and took three trees such as one Sonaijhuri, one Mango and one Palash.

6. That the accused persons after assaulting the complainant left the place with three trees.
7. That the complainant any how came to his house with the help of Laxmi Mondal and Khitish Mondal who had been to the spot at the time of occurrence and they also saw the attack of the accused persons over the complainant.
8. That the complainant was taken to Thana and thereafter he was admitted at Hura BPHC as the condition of the complainant was serious so he was referred to Purulia Sadar Hospital.
9. That the attending physician attached to Purulia Sadar Hospital examined the complainant and X-Ray and scan was done and

ultimately he was discharged on 01-01-2017. The complainant is still groaning with pain.

10. That the accused persons are still criminally intimidating complainant and his family members.

11. That the accused persons has committed the offence punishable under Sections 326/427/447/506/379/34 of the I.P.C.

12. That the complainant lodged complain before Police and thereafter on 09-01-2017 written version was submitted before S.P, Purulia but did not take any actions against the accused persons.

13. That all the documents are lying in the hospital, complainant is a poor man. Police has not taken any action against accused persons.



It is prayed that your Honour would be pleased to treat this petition of complaint as F.I.R under Section 156(3) of Cr.P.C and necessary order be passed directing the O.C of Hura P.S to start a case.
