- 2) That on 14/11/2016 at about 3:00 to 3:30 P.M all the accused persons lifting water with the help of water pump set from the pond of the complainant without knowledge and permission of the complainant.
 - 3) That the complainant seeing such illegal activities on the part of the accused person objected their act and asked them to stop the pump set unless the fish reared by him from the pond due to shortage of water. It may be pointed out that the pond where from the water was lifting by the accused persons belonged to the complainant and he has exclusive owner of the same, but the accused persons have no right over the said pond in-spite of that they falsely and illegally without any permission of the accused persons was lifting water.
 - 4) That in course thereof both the accused persons assaulted the complainant with the help of a spade over the partial region over his head and also with the help of lathi. Due to such assault the complainant sustained grievous injuries on his person. And that the complainant have taken to Ilara Rural Hospital and after Purulia Sadar Hospital for better treatment and the complainant was admitted as an indoor patient.
