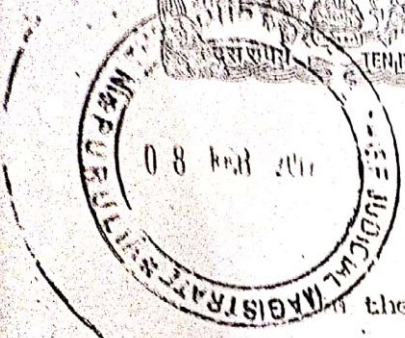

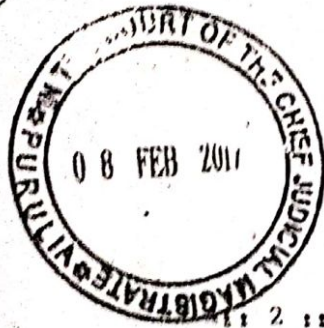

2.---That your petitioner is a practising Lawyer of Purulia District Judges' Court and for the sake of his profession your petitioner has to stay at Purulia and he also goes and comes to his native village Mourangdih to look after and supervise his paternal properties.

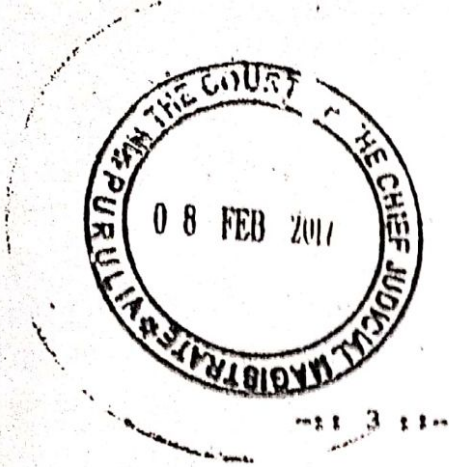
3.---That on 08-01-2017 at about 4 p.m. when the petitioner reached to his residential house he noticed that the accused was taking ^{the Guava tree} the Guava tree of the complainant which was standing in the court-yard of the complainant by cutting the same.

4.---That the complainant also noticed that the accused damaged the Chala roofed with tiled and took away the Shaped logs(Lara) of Shal woods and other valuable wooden logs.

5.---That the complainant having noticed the same raised protest against the illegal and wrongful acts on the part of the accused. The accused at this turned vindictive and became adamant and abused the complainant with filthy languages and threatened

6.---That the wooden logs which the accused took away worth Rs.10,000/- . (Ten thousand)

7.---That the complainant and the witnesses witnessed the same.

8.---That the accused thus committed the offences punishable U/s 447, 448, 427, 379, 304, 506 I.P.C.

9.---That your petitioner reported the incident to the local police and then to the Superintendent of Police, ^{Pamth} The Superintendent of Police acknowledged the same. But it is a matter of regret that neither the local police nor the Superintendent of police took any action against the accused person.

Hence the petitioner is left with no other option but to file this case herein court. There is a question of search and seizure so a police case is desirable.

It is prayed that your Honour may be graciously pleased to pass necessary order directing the police of Hura P.S. to investigate the case in accordance with law treating this petition as F.I.R.
