Sub: - Complaint against Manas Kumar Mahato (32 yrs) s/o Banerwar Mahato of Village Hatibari PS Hura Dist. Purulia to start a case U/S 46A(C) B.E. Act.

Sir,

In producing here with arrested accused namely Manas Kumar Mahato (32 yrs) s/o Banerwar Mahato of Village Hatibari PS Hura Dist. Purulia along with seized Foreign Liquor/Country Spirit bottles details of seized articles are mentioned in attached seizure list, I beg to submit that today on 8.3.17 in between 18.55 to 19.25 hrs acting on a credible source information I SI Bablu Ghosh of Hura PS along with ASI Salil Chakraborty and force held raid in the Grocery Shop cum house of Manas Kumar Mahato s/o Banerwar Mahato at village Hatibari under Hura PS against illegal stock and selling of liquor and during the time of raid found that the above noted accused person was stocking and selling country spirit/Foreign liquor bottles, which were kept his grocery shop as well as a room inside of his Grocery shop at village Hatibari under Hura PS Dist Purulia. I asked to produce him any valid documents/ Licence in respect of selling and stocking Country Spirit/Foreign Liquor but he failed to produce the same. So he committed offence U/S 46A(C) B.E. Act Accordingly, I arrested him after preparing proper Arrest Memo, maintained all formalities regarding arrest, informed ground of arrest and supplied one copy of Memo of Arrest to him. Then, I seized all the sealed Foreign Liquor/Country Spirit bottles (details are in attached seizure list) and sale proceed money Rs 145 after preparing proper seizure list duly signed by the witnesses and labeled sample one bottle each. This is to note here that on seeing police personnel all public/customers leave the place. Total 35 (thirty five) bottles liquor (Officer Choice 7 bottles, DILKHUSH 24 bottles and Kingfisher Beer 4 bottles) have been seized; each bottle of Officer Choice measure 180 ML and value Rs 100/- each, Each bottle of DIL KHUSH measure 600 ML and value Rs. 30 each bottle of Kingfisher Beer measure 650 ML and value Rs 100 each. Total value of seized liquor is Rs 1820/- (one thousand eight hundred and twenty only).

Under the above circumstances and fact, I therefore pray that a Cog. Case U/S 46A(C) B.E Act may kindly be started against the arrested accused Manas Kumar Mahato (32 yrs) s/o Banerwar Mahato of Village Hatibari PS Hura Dist. Purulia and arrange for its investigation.
