Sub: - Complaint against Uttam Mahato(23 yrs) s/o Chittaranjan Mahato of Village Hatibari PS Hura Dist. Purulia to start a case U/S 46A(C)B.E. Act.

Sir,

In producing here with arrested accused namely Uttam Mahato(23 yrs) s/o Chittaranjan Mahato of Village Hatibari PS Hura Dist. Purulia along with seized Foreign Liquor/Country Spirit bottles details of seized articles are mentioned in attached seizure list). I beg to submit that today on 8.3.17 in between 20.15 to 20.45 hrs acting on a credible source information I ASI Salil Kr. Chakrabarti and other officer and force held raid in the Grocery Shop cum house of Uttam Mahato s/o Chittaranjan Mahato at village Hatibari under Hura PS against illegal stock and selling of liquor and during the time of raid found that the above noted accused person was stocking and selling country spirit/Foreign liquor bottles, which were kept his grocery shop as well as a room inside of his Grocery shop at village Hatibari under Hura PS Dist Purulia, On demand, he failed to produce any valid documents/ Licence in respect of selling and stocking Country Spirit/Foreign Liquor. So he committed offence U/S 46A(C) B.E. Act Accordingly, I arrested him after preparing proper Arrest Memo, maintained all formalities regarding arrest and supplied one copy to him. Then, I seized all the sealed Foreign Liquor/Country Spirit bottles (details are in attached seizure list) and sale proceed money Rs 125 after preparing proper seizure list duly signed by the witnesses and labeled sample one bottle each. This is to note here that on seeing police personnel all public/customers fled away. Total 41 (Forty one) bottles liquor (MC DOWELLS No.1- 6 bottles, DILKHUSH 29 bottles and Kingfisher Beer 6 bottles) have been seized; each bottle of MC DOWELLS No.1 measure 180 ML and value Rs 90/- each, Each bottle of DILKHUSH measure 375 ML and value Rs. 19 each bottle and each bottle of Kingfisher Beer measure 650 ML and value Rs 100 each. Total value of seized liquor is Rs 1691/- (one thousand six hundred and ninety one only)

Under the above circumstances and fact, I therefore pray that a specific Case U/S 46A(C) B.E Act may kindly be started against the arrested accused Uttam Mahato(23 yrs) s/o Chittaranjan Mahato of Village Hatibari PS Hura Dist. Purulia and arrange for its investigation.
