
In producing here with arrested accused namely Rabi Gorai (28 yrs) s/o Dharu Gorai of Lalpur PS Hura Dist. Purulia along with seized mobile phones (details of seized articles are mentioned in attached seizure list), I beg to submit that today on 21.3.17 in between 11.45 to 12.45 hrs acting on a credible source information I SI Swapan Majumdar along with other officer and force held raid and search in "RABI VERITIES" of above noted accused person at Lalpur more, beside Puncha Road under Hura PS and during the time of search it is found that the above noted seized mobile were keeping conceal condition in side of his "RABI VERITIES" shop. On interrogation he could not give any satisfactory answers and he gave different statements in different times in respect of the said mobile phones. I served notice to the shop owner Rabi Gorai to produce any valid documents in respect of the said mobile phones, But he failed to produce any valid documents in respect of the said mobile phones. I also given him sufficient time to produce valid document in respect of the seized mobile phones but he failed to produce any documents. So it is strongly believed that those mobile sets were keeping by him either by means of fraudulent or theft. Accordingly, I arrested him after preparing proper arrest memo, maintained all formalities regarding arrest as he committed offence U/S 379/411/414 IPC. Then, I seized three (3) numbers of mobile phone (1) One golden colour SAMSUNG mobile Phone Vide Model no-J210F (2) One black/red colour opal mobile set vide Model no-R-600 and One black colour NOKIA mobile set vide Model no-C-2-00 by preparing seizure list duly signed by the witnesses and accd. persons with proper sealed and labeled.

Under the above circumstances and fact, I therefore pray that a Cog. Case U/S 379/411/414 IPC may kindly be started against the arrested accused person namely Rabi Gorai (28 yrs) s/o Dharu Gorai of Lalpur PS Hura Dist Purulia and arrange for its investigation.
