


Sub: Complaint against Goutam Mudi (23 yrs) s/o Sasthi Charan Mudi of Village Baragram P.S. Hura Dist. Purulia to start a case U/S 46A(C) B.E. Act.

Sir,  
In producing here with arrested accused namely Goutam Mudi (23 yrs) s/o Sasthi Charan Mudi of Village Baragram P.S. Hura Dist. Purulia along with seized Country Spirit bottles (details of seized articles are mentioned in attached seizure list), I beg to complain that today on 25.3.17 in between 19.25 to 20.05 hrs acting on a credible source information I SI Bablu Ghosh along with ASI Jhantu Dalal and force of Hura P.S. held raid in the Gumti Shop of Goutam Mudi s/o Sasthi Charan Mudi at Baragram more under P.S. Hura against illegal stock and selling of liquor and during the time of raid found that the above noted, accused person was stocking and selling Country Spirit bottles (Dil Se & DIL KHUSH); which were kept his Gumti shop at Baragram more under Hura P.S. Dist. Purulia. I asked him to produce any valid documents/ Licence in respect of selling and stocking Country Spirit bottles but, he failed to produce the same. So he committed offence U/S 46A(C) B.E. Act Accordingly, I arrested him after preparing proper Arrest Memo, maintained all formalities regarding arrest, informed, ground of arrest and supplied one copy of Memo of Arrest to him. Then, I seized all the seized Country Spirit bottles (details are in attached seizure list) after preparing proper seizure list duly signed by the witnesses and accused. I also labeled sample one bottle each. This is to note here that on seeing police personnel all public/customers leave the place. Total 47 (Forty seven) bottles liquor (Dil Se and DIL KHUSH), Dil Se- 25 bottles, and DIL KHUSH-22 bottles measuring 600 ML each bottle and value Rs. 30 each. Total value of seized liquor is Rs 1410/- (one thousand four hundred and ten only).

Under the above fact and circumstances, I therefore pray that a Cog. Case U/S 46A(C) B.E. Act may kindly be started against the arrested accused Goutam Mudi (23 yrs) s/o Sasthi Charan Mudi of Village Baragram P.S. Hura Dist. Purulia and arrange for its investigation.
