has committed theft of electricity U/S 135 of The Electricity (amendment Act-2007).

On 30-03-2017 at about 03.10 p.m. I Shyam Sunder Murmu, S.M Hura C.C.C along with:

Entered the premises of Abhinash Lohar s/o Lt Chandan Lohar, village: Dumkadih, P.O. Kulgora, P.S. Hura,

and inspected his/her premises. During inspection theft of electricity was detected i.e. he/she was using electricity dishonestly by drawing illegal hooking from the nearest L.T.O.H line of W.B.S.E.D.C.L. i.e. U/S 135 (I) (a) was detected.
