

The humble petition on behalf of the  
above named petitioner:

Most respectfully sheweth :-

1. That on 29/12/2016 in morning the petitioner went to his land bearing plot No. 519 where he used to grow biri and other seeds.
2. That at about 9 - 9.30 A.M. Birbal Mondal entered into the land and told the petitioner to go homeward they will cut the <sup>trees</sup> seeds. The petitioner made protest but Birbal called his two brothers namely Subhas Mondal and Kashinath Mondal. They came and their father Robilochan Mondal and Sapi Mondal S/o Kashinath Mondal also came and entered into the land of the petitioner.
3. That under direction of Robilochan Mondal all other accused persons assaulted the petitioner with back side of spade in chest. and with Bhojali in his left palm. The petitioner became senseless and fell down over the land.
4. That the accused persons cut six palash trees and took them. They left the place. While they saw that the sons were coming towards the field. Prabhalla Chandra Mondal Trilochan Mondal and one Bibir Mondal took the petitioner to Hura B.P.H.C. for treatment. Hura B.P.H.C. referred the petitioner to Deben Mahato Sadar Hospital at Yuxulia.
5. That the petitioner was discharged from hospital and thereafter went to Hura Police Station to lodge a contd... P/3.
